#### **ADDITIONAL FEES**

# CONTINUING EDUCATION CREDITS

The Division of Psychoanalysis is approved by the American Psychological Association (APA) to sponsor continuing education (CE) for psychologists. Division 39 maintains responsibility for these programs and their content. Wednesday Master Classes and Spring Meeting programs are open to all mental health professionals; participants may receive CE credit for attending these programs. Participants from professions other than psychology should consult with their respective licensing boards regarding the acceptance of APA-approved Certificates of Attendance as documentation of CE. For programs sixty minutes in duration or longer, one credit is awarded for each hour of CE activity, with additional quarter-increments of CE credit awarded beyond one hour; for example, attending a one-hour-and-fifty-minute program will yield 1.75 CE credits. **50-minute programs are not available for CE credit.** 

Division 39 is currently in the process of applying to be approved as a continuing education provider for <u>licensed master social workers</u> and <u>licensed clinical social workers</u> in the state of New York. We hope to be officially approved well in advance of the spring meeting in April.

Wednesday Master Classes require registration separate from general registration for the Spring Meeting and are offered for additional fees. At the conclusion of Master Classes, participants will receive a paper certificate of attendance upon completing a *paper* evaluation form on site.

Complete descriptions of each Wednesday Master Class and other CE-eligible programs (title, presenter(s), learning objectives, instructional level) can be found on the Division 39 website: www.division39.org. The website will be the most complete source of information about CE-eligible programs; participants are encouraged to use this information when making decisions about attending the Wednesday Master Classes and/or Spring Meeting programs offered from Thursday through Sunday.

Each CE-eligible Spring Meeting program is identified by a letter/number code (e.g. TH-1, FR-3, SA-5, SU-2) indicating the day of the presentation and its order in that day's schedule. For all CE-eligible programs, there is no partial credit for attending only a portion of an eligible program. Attendance of CE-eligible Spring Meeting programs will be confirmed using a scanning system. Participants will be required to have the barcode on their badges scanned both at the start of the program session and as they leave at the conclusion of the session. To receive a Certificate of Attendance for any CE-eligible program, it is necessary to

(1) register for the Spring Meeting, (2) attend the entire presentation, and (3) submit a completed evaluation form through Express Evaluations, the Division's online evaluation and certificate service. **Please note our transition away from paper evaluations to online evaluations!** Instructions for using Express Evaluations will be available at the Registration Desk and included in each attendee's packet of materials received during registration.

Division 39 is committed to accessibility and non-discrimination and conducts CE activities in conformity with the APA Ethical Principles for Psychologists. There is no commercial support for any of the Wednesday Master Classes or Spring Meeting CE programs; all presenters have denied the existence of any relationships (e.g. research projects, grants or other funding/support) that could be construed as conflicts of interest. Presenters of CE-eligible programs will address, whether during the program or via a list of references, the utility of the presentation content and the basis for these statements as well as the limitations and risks associated with the program content. Presenters and participants are asked to honor the need for privacy and confidentiality throughout these programs. # Affect Regulation Theory: The Broad Strokes Dan Hill, PhD

There are two affect regulating systems. Both develop in the attachment relationship. One develops early (8–18 months) and is foundational. It operates instantaneously and involuntarily; our gut reactions. The other develops later (2–6 years) and is a conscious, deliberate, verbal reflective system (mentalization). Affect regulation theory proposes that personality disorders and other developmental psychiatric disorders derive from early attachment trauma and its effects on the capacity to regulate affect.

This master class will provide the broad strokes of affect regulation theory with a focus on the primary affect regulating system. It will take up the following topics:

- · What is affect and what is affect regulation?
- How does a robust capacity to regulate affect develop out of the secure attachment relationship?
- How do deficits in the capacity to regulate affect develop out of the insecure attachment relationships?
- How do deficits in affect regulation develop into personality disorders and other psychiatric disorders?
- How does psychotherapy repair the capacity to regulate affect?

Witnesses to Genocide: The Traumatized Patient and The Wounded Healer

Elizabeth F. Howell, PhD; Emily Kuriloff, PsyD; Sheldon Itzkowitz, PhD

In an era in which the analyst's "irreducible subjectivity" is accepted as a given, this course will focus specifically on the impact of the analyst's traumatic past on her work with traumatized patients. From an historical, theoretical, and moreover a clinical perspective, course instructors will explore the advantages, challenges, and pitfalls inherent in a "traumatized dyad," with the goal of expanding awareness, curiosity, and communication. Formal instruction will be accompanied by a video featuring pioneers in the psychoanalytic treatment of trauma who discuss their own battles with their traumatic memories, both as patients and as analysts.

# On Dreams and Dreaming: Expanding the Dream Frontier Mark Blechner, PhD

In this class, we will study new ways of working with dreams in psychoanalysis, as well as new theories of the significance of dreams in mental life and how they are formed. Do dreams bring to light issues that are not revealed in free association? Do they have special importance in cases of "reanalysis"? We will explore group approaches to dream analysis, like those of Montague Ullman and Robert Bosnak, and compare them with one-on-one dream work in clinical treatment. We will also consider how studies in neuropsychoanalysis have strengthened our understanding of dreams.

Transference-Focused Psychotherapy (TFP) for Borderline Disorders and Narcissistic Personality Disorders

Diana Diamond, PhD; Barry Stern, PhD

Transference-Focused Psychotherapy (TFP) is a manualized, evidence-based treatment for severe personality disorders, in particular borderline and narcissistic personality disorders. TFP combines a psychodynamic approach with structure and limit setting. The aim of the treatment is to modify maladaptive internalized relationship patterns characteristic of personality disordered individuals by exploring them as they are activated in the therapeutic relationship and in the patient's interpersonal life. The ultimate aim is to create more stable, realistic and better-integrated mental representations, leading to diminished symptoms, self-destructiveness, and improved interpersonal and self-functioning, and adaptation to life.

The Psychotherapist's Subjectivity: "Dialogue of Unconsciouses" and Use of Self in Contemporary Relational Technique

Anthony Bass, PhD; Steven Kuchuck, LCSW

Making use of didactic and experiential approaches to this subject, we will explore the impact of the therapist's life experience and psychological make-up on the therapeutic process. We will focus on the relationship between the clinician's subjectivity, theoretical orientations, and approach to technique. The use and impact of the therapist's subjectivity will be considered in relation to questions of self-disclosure, and other clinical choices.

Attendees may present material themselves or work with others' clinical vignettes.

Striking When the Iron's Cold? Exploring the How, When, If, and Why of Pursuing Psychoanalytic Training.

In this workshop, panelists will invite participants to think about both the practical and theoretical questions involved in considering if, how, why, and when to pursue psychoanalytic training. Panelists will specifically address issues of timing in one's career and personal life, reasons for pursuing training and what to expect, training model options, and pragmatic considerations such as how to manage ongoing responsibilities in one's life with one's own analysis, patient caseloads and analytic supervision. Larger questions about the continued professional relevance of psychoanalytic training will also be discussed. Comprised of clinicians who came to psychoanalysis at different stages in their careers and lives and who range from a Director of Training to a contemplating clinician, this discussion welcomes therapists at all stages of career and development who want to explore if psychoanalytic training is right for them.

They will explore the suffering endured by both victim and perpetrator and will discuss the vital role of witnessing and acknowledgement in the healing of the wounds of violence. The forces that both facilitate and inhibit the recognition of suffering in relationships—between people and between nations—will be explored. The perspectives that the panelists bring to the discussion have been enriched by their pioneering work with violence in prisons, war zones, schools, and communities, and by the development of concepts and experience with trauma in recent years.

**Bertram P Karon PhD** is a former President of the Division (1990-1991); Diplomate in Psychoanalysis, American Boards of Professional Psychology; Professor of Psychology, Michigan State University; author of 151 articles in professional journals, 51 book chapters, and three books, the most important of which is Karon and VandenBos, *Psychotherapy of Schizophrenia: The Treatment of Choice.* This book

describes the nature of schizophrenia, how to treat schizophrenia (psychoanalytically), and a randomized blind study comparing treatment by medication, medication combined with psychoanalytic therapy, and psychoanalytic therapy without medication. Medication combined with psychoanalytic therapy was more effective than medication alone, medication combined with psychoanalytic therapy was more effective if the medication was withdrawn rather than continued. But most effective was psychoanalytic therapy without medication.



**Dorothy Evans Holmes, PhD,** is a Teaching, Training, and Supervising Analyst in the Psychoanalytic Education Center of the Carolinas. She is Professor Emeritus at the George Washington University where she was Program Director and Director of Clinical Training of the Professional PsyD Program. She is also a Teaching, Training and Supervising Analyst Emeritus at the Baltimore Washington Institute for

Psychoanalysis. Dr. Holmes has written extensively on intrapsychic influences of race, gender and their impact on psychoanalytic treatment process. Currently, she serves on the Board of Directors, National Register of Health Service Psychologists, the Program Committee of the American Psychoanalytic Association (APsaA), and its Task Force on Diversity. Dr. Holmes has received numerous honors for her scholarly work on cultural factors and cultural trauma. Including being the Plenary Speaker for the National Meeting of the APsaA, January, 2016. She is in private practice in Bluffton. SC.



**Steven Reisner, PhD,** is a psychoanalyst and couples therapist in New York City. He is a founding member of the Coalition for an Ethical Psychology, Advisor on Psychology and Ethics for Physicians for Human Rights and past-President of Psychologists for Social Responsibility. He has been active in combating torture in all its forms, and was a leader in the movement to remove psychologists and other

health professionals from their central role in the CIA's and the U.S. military's torture program. After 10 years, this effort was successful, and it is no longer considered ethical for psychologists to be part of any national security operation that systematically violates international human rights law or the United Nations Convention Against Torture. As a result of this new policy, psychologists were removed from Guantanamo Bay in January 2016. In addition to his political advocacy, Dr. Reisner has been on the faculty of the Clinical Psychology Program at Columbia University, the International Trauma Studies Program at New York University, the NYU Medical School, the Institute for Psychoanalytic Education, and the Women's Therapy Center Institute. He has been a consultant

on issues of trauma, torture, political violence, disaster and resilience in the face of catastrophic events for the United Nations, the International Criminal Court, the U.S. State Department and other international humanitarian and mental health organizations. He has trained clinicians following war and disaster in Kosovo, Iraq, Haiti, East Africa, and elsewhere. Dr. Reisner is the co-author of two PHR monographs on health professionals and torture, and has been interviewed widely. In an earlier career, Dr. Reisner was an Obie-award winning director and actor.



Stephen Soldz, PhD, is a psychologist and psychoanalyst on the faculty of the Boston Graduate School of Psychoanalysis, where he directs their Social Justice and Human Rights program. Over the last decade, he has been a leader in efforts to remove psychologists from participation in torture, to end the APA's collaboration with the torture program, and to call attention to ethically compromised involvements of

psychologists in other national security operations. Stephen is a past president of Psychologists for Social Responsibility, a cofounder of the Coalition for an Ethical Psychology, a member of the Section V Board, and a Division 39 representative to the APA Council of Representatives. He publishes widely on the intersection of psychology and social issues, as well as in the research literature. He coedited Reconciling Empirical Knowledge and Clinical Experience. Stephen has been interviewed by press from around the world and was a consultant on several Guantánamo cases.
